**Rules & Regulations for Transport**

1. This is a nodal point system. Parents are requested to select nearest nodal point.
2. In case of midterm admissions, the transport fees to be paid for entire Term. Transport department will confirm seat subject to available vacancy in that particular route. If seat is not available then it will be in the waitlist till vacancy is created or will get transport facility from next term only.
3. In case of Withdrawal from school Transport during ongoing Term, that term fees will not be refunded, In case fees has been paid for Full year, and want to withdraw in Term 1, then Term II full fees shall be refunded.
4. Transport fees to be deposited as per below mentioned due dates prior start of Term. If not paid within time then facility will not be provided for that particular term.
5. Due dates for payment of fee: Term 1 - Transport fee to be paid before 20<sup>th</sup> March by Cash/Card. NEFT/Online Payment will not be accepted. Term 2 Transport fee to be paid by Cash/Card before 12th September or PDC of 12th September to be deposited.
6. Bouncing of the Cheque will be considered as consent for withdrawal of your ward from transport facility.
7. Any Delay in payment of Transport fees will attract a penalty of Rs.50/- per day after due date including the day of payment.

My child is being enrolled in your school, MIS International School, Balewadi Purie, (The "school" as mentioned above) In this respect, we request you to kindly provide the school bus facility to our child for pick-up and drop, to and from our pre-selected nodal point to the school. In this respect, we are aware and acknowledge that for the convenience of the parents, the school is entering to in arrangement with Bus operators for providing bus facility to the school students.

We hereby give our consent and authorize the school to finalize one or more appropriate operators or providers of buses to facilitate travelling of the students to attend the school,

We understand that all steps and precautions will be taken to ensure safety of my ward. However we undertake and assure to follow the norms and guidelines as may be prescribed by the school time to time and pay appropriate charges for buses services including any increase because of inflation, increase in fuels price, additional statutory cost etc.

I further agree, confirm and bind myself, my heirs, executors and administrators that we will keep the school, its management and employees fully indemnified in respect of all claims, losses, liabilities or damages made against, suffered or incurred by the school, its management and/or employees (despite no gross negligence/fault on their part), as a result on any work, acts mishap etc. by bus operator / contractors or any of their employees or agents during and/or in connection with the journey and School bus facility provided to our child as mentioned herein.

I nor my executors or administrators or other legal representatives will make any claim against the school, its management and employees in respect of any loss and injury to property or person including injury which my child/ student may suffer while the child being so boarding, alighting and travelling in the school Bus and I understand and agree that no compensation will be paid by the school, its management and/ or employees in respect of any such loss or injury. This request and undertaking will be valid till such time as school bus facility is being provided to our child.
